Conozca Sus Derechos En su Negocio | At a Business

Espacio Publico | Public Space

En áreas públicas, ICE puede ingresar sin una orden judicial (salas de espera, comedores, baños, etc.)


Rechazar el servicio O decir:

“Esta es un área privada. No puede entrar sin una orden judicial.”

In public areas, ICE can enter without a warrant. (i.e. waiting rooms, dining spaces, restroom, etc)

Refuse service OR say:

“This is a private area. You may not enter without a judicial warrant.”



Espacio Privado | Private Space

Areas restringidas: cocinas, oficinas, almacenes, etc.

El gerente/propietario puede negar el acceso a ICE sin una orden judicial.

Si ICE tiene una orden:

- Mantén la calma y pide ver la orden para verificar una orden judicial.
- Si es válida, un miembro del personal designado debe cumplir con la orden.
- Los demás deben permanecer en silencio y evitar involucrarse para proteger a quienes no estén nombrados en la orden.

CONSEJO

Designa personal capacitado como punto de contacto con ICE.

Coloca señales claras como:

- “Área Privada – Solo Personal Autorizado”
- Esto aclara tus derechos y establece límites.

Restricted areas: kitchens, offices, storage, etc.

The manager/owner can deny ICE access without a warrant.

If ICE has a warrant:

- Stay calm and ask/confirm if it is a judicial warrant.
- If valid, one designated staff member should comply with the warrant.
- Others should remain silent and avoid involvement to protect those not named in the warrant.

TIP

Designate trained staff as point people for ICE interactions.

Post clear signs such as:

- “Private Area – Staff Only”
- This states your rights and sets boundaries.

En Casa | At Home

NO ABRA LA PUERTA | DON'T OPEN THE DOOR



- Comuníquese por una ventana ó puerta cerrada. La migra solo puede entrar con **una orden judicial firmada**.
- Communicate through a window/closed door. ICE can only enter with a **signed judicial warrant**.

GUARDE SILENCIO | REMAIN SILENT



- Tiene el derecho de guardar silencio, úselo. Diga en voz alta que no va a contestar preguntas ni firmar nada sin un abogado presente.
- You have the right to remain silent. Don't answer questions or sign anything without a lawyer present.

APUNTE DETALLES | DOCUMENT DETAILS



- Tome fotos, videos, y escriba detalles (cuántos agentes están presentes, qué vehículo manejan). Al grabar video, no incluya a la persona siendo interrogada, si no enfóquese en los agentes
- Take pictures, videos, & write down details (How many agents, types of cars). Only film agents, not the person being detained.
